As I write this, winter has officially arrived. Football and hockey games in Buffalo have been rescheduled and airports have closed due to heavy snow. Temperatures in western Canada are setting record lows with temperatures reaching -45 °C.

Many precasters shut down during the coldest winter months to conduct equipment maintenance or to enjoy a well-deserved vacation south. For those that continue production, making quality concrete in these conditions requires special considerations.

Freezing weather, snow and ice can have significant detrimental effects on the quality of your products. For those plants that store aggregates outside, large lumps of ice and snow can accumulate in your aggregate and eventually end up in your mixer. It is important that all ice has melted prior to final mixing and discharging the concrete. Ice that remains in the mix will create voids in your product once it melts. The added water from melting ice and snow will raise your water/cement ratio if not properly accounted for. High water/cement ratios lead to lower ultimate strength, reduced durability, increased permeability, and generally poorer quality concrete.

gates indoors, utilize storage bins that circulate steam or hot water through pipes or adding hot water to the mix. CSA A23.1 states that concrete leaving the mixer must be at least 10 °C to ensure proper curing and strength gain. Your plant should also maintain a minimum air temperature of 5 °C during the curing period. If you are moving moulds in from the yard when changing production runs, make sure all water, snow and ice are removed. It is good practice to keep the moulds inside overnight prior to pouring so they acclimatize and reach room temperature. When it is cold in the plant, you may want to leave the product in the mould longer to reach your minimum stripping strength. CSA states that 7MPa is considered the minimum compressive strength that concrete must achieve to eliminate the risk of frost damage. Minimum stripping strength to prevent damage varies by product but is usually in the 20 MPa range.

There is much to consider when producing concrete products during the winter months but if done correctly, your concrete will continue to be strong and durable.

IN MEMORY OF MEL C. MARSHALL



On November 11th of 2023, the CPA, along with the precast concrete industry as a whole, lost one incredible human being. Mel Marshall passed away peacefully at Mount Sinai Hospital in Toronto. Mel was 85 years old and an icon in the industry. He worked in precast plants, ran precast plants, ran a steel plant, and knew more about precast concrete than anyone you could meet. He started a consulting business helping precasters set up new plants, upgrading production lines and solving problems. He'd often recommend products and brands to customers and eventually started representing for the companies whose products he liked. Mel was the most unlikely of salesmen, as he was never selling, just helping. I don't think Mel ever made "the Hard Sell" in his life. In fact, he barely put on the salesman hat at all. He would just visit precasters and help them with advice, experience and expertise. solve problems, recommend solutions, and he might leave you a brochure outlining his product line... but he probably wouldn't mention it. But it worked for him, and it worked for precasters.

Mel has been with our association since the beginning, helping us draft our charter, instructing us on the proper way to organize our board of directors, hold elections, make motions, that sort of thing. (Most of us concrete workers had never heard of Roberts Rules, much less owned a copy). Mel was already working with Precast Associations in California and British Columbia. Once we got going, he was one of the first supplier members to help sponsor our annual convention and encouraged other suppliers as well. I think he was the first "Supplier Rep". Whenever there was a meeting or convention, Mel was there, flying in from BC (or wherever else in the continent he might be). He never missed. And then there was the production schools. He hosted them whenever and wherever we wanted. An all day event that he never charged us a nickel for. It was probably the thing he loved the most (except maybe hockey.) He'd stand at the front of a room full of guys, (some of whom hadn't seen the inside of a classroom since they were kicked out of one in grade 8) and entertain them, teach them and just talk to them.

Mel's greatest gift was his charisma. When he talked to people, he engaged with them, and was genuinely interested in what they had to say. Whether it was the youngest guy in a production school or the CEO of a Fortune 500 company, he connected with them directly, almost intimately. Precasters would have guys come back from production school and say "I told Mel about that and he told me to do this". Not "the teacher" or "the old guy at the front" or even" Mr Marshall" It was "Mel", like they were friends. It was a gift.
